2025 NCS USBCA Men's Championship Tournament Rules/General Information

1. This tournament is certified through the United States Bowling Congress (USBC) and rules not covered on this form are governed by the USBC rules and regulations.
2. Eligibility: Participants must hold a current USBC membership card and be a member of the North Carolina State USBC Association (NCS USBC) at time of participation.
 - a. NCS USBC limits the number of professional bowlers and non-NC bowlers on any team to two (2) and one (1) on any doubles. Participants must indicate if they are a PBA Member at time of entry
3. Average:
 - a. Highest USBC league average 2024-25 with 21 games including Summer Averages.
 - b. If you did not bowl in the 2024-25 season; you can use your current average of 21 games or more as of Oct 1st, 2025. You must submit or bring proof of your current average prior to bowling your first event, otherwise; bowler will have a 230 average.
 - c. USBC Rules 319 a-e will apply. Refer to USBC Playing Rule Book to understand this rule in its entirety. Bowlers must report if their average is affected by this rule prior to competing. Failure to do so will result in disqualification.
4. Handicap will be based on 90% of 230
5. Entrants may bowl team, doubles, and singles. Entrants may bowl twice in team event with the second entry changing a minimum of two (2) bowlers and both entries and fees must be submitted at time of entry. Entrants must enter both doubles and singles if entered in either and are only allowed to bowl once. All Events will be based on first scores bowled only.
6. Entry Fees Based on Per Person, Per Event: Handicap = \$18.00 lineage & expense, \$17.00 prize (Total = \$35.00). Optional Fees, Per Person, Per Event: \$10.00 each All Events Scratch and Handicap. Scratch Team, Doubles, & Singles will be available for \$10 per person, per event. All optional fees go directly to the appropriate prize fund. Just handicap total fees per bowler = \$115.00. Everything handicap & scratch total fees per bowler = \$155.00
7. Prize Fund: Prize funds for the various events will be returned 100% based on a minimum ratio of 1:6 for Team, 1:6 for Doubles/Singles, 1:10 for All Events (handicap and scratch).
8. Line Up: There shall be no changes in the line-up once the entry form has been submitted. Substitutes will take the position of the absent bowlers.
9. Please submit multiple team entries together with the same team captain listed to ensure teams are bowling together. No lane assignment changes will be made on the day of the event.
10. Lanes will be re-dressed after each squad.
11. Entrants are expected to participate in acceptable bowling attire. No tank tops or shirts with inappropriate language or graphics are allowed.
12. In case of a tie for the championship in any event, all teams tied will be declared co-champions.
13. All money won over \$600.00 – social security number must be given to TM before bowling any squad. If not reported before bowling this will automatically disqualify the bowler and no funds will be refunded once the squad has started.
14. Entries will be scheduled on a first-come basis. The Tournament Manager has the right to make changes to the bowling schedules to ensure all squads are properly filled.
15. Method of payment: Make checks payable to: NCS USBCA Men's Championship Tournament; only one check per entry. If a check is returned, the amount of the check plus an additional return check fee of \$30.00 will be charged. This amount must be paid by October 5th, 2025, via cashier's check or money order prior to bowling squad or entrants will not be allowed to bowl.
16. Entries may be canceled and fees returned prior to the close of entries. In the event a team must cancel after the tournament entries have closed, all funds will be forfeited. If team no-shows, all funds will be forfeited. In the event of unforeseen circumstances, emergencies, weather issues, or any other incident deemed an emergency by the TM, funds may be returned to the bowler at the discretion of the tournament manager.
17. Per USBC Guidelines tournament standings and winnings will be finalized and distributed within 30 days of the close of the tournament. Please do not contact the tournament manager or bowling center asking for checks until after this period.
